Overview

Part of the aspiration of the four purposes as the starting point for schools' curriculum design – to support its learners to: 'communicate effectively in different forms and settings, using both Welsh and English'. One of the seven goals of the Well-being of Future Generations Act is: 'A Wales of vibrant culture and thriving Welsh language – where we have lots of opportunities to do different things and where lots of people can speak Welsh' and finally, our students are an integral part of 'Cymraeg 2050: A million Welsh speakers Strategy', shows the importance of a robust and rigorous approach to developing our students as Welsh speakers.

Cymraeg responsibilities

Planning for the development of Welsh Language provision is a mandatory element of Curriculum for Wales

Leadership Team

- Develop a clear vision of the Welsh language within the curriculum design
- Ensure the governing body understand and lead on their responsibility for the Welsh Language
- Create a school language policy
- Ensure staff are aware of the linguistic background and ability of all learners
- Monitor and evaluate Cymraeg across the school
- Identify staff training needs

Head of LLC

Strategically plan for the development of Cymraeg through:

- Develop a strategy for whole school Welsh ethos and a language that can be seen and heard
- Create Siarter laith (Welsh Language Charter) in conjunction with the Welsh Literacy TLR holder
- Engage parents and the community in Welsh language events
- Improve practitioners' Welsh language skills across the school
- Liaise with CWRE TLR holder to develop opportunities for students to understand the benefits of bilingualism in the world of work

Welsh Literacy (TLR)

- Use of research to improve progress in Welsh lessons and in using Welsh across the school
- · Build student and staff confidence in using the language
- Develop students' skills in speaking, listening, reading and writing
- Develop pride in Welsh language, culture, history and heritage
- Liaise with community organisations to enable students to access Welsh language opportunities outside of school





 Organise whole school celebrations of national festival days and events that promote the Welsh language

Subject teachers

- Ensure that students use Welsh dates in their work across all subjects except English and French
- Encourage 'classroom' Welsh for example students asking for a pen or to go to the toilet, counting down etc.
- Access professional development opportunities to improve own confidence and understanding of Cymraeg
- Use Welsh where possible in greetings and other interactions with students and staff
- Use Welsh language CWRE opportunities within each subject area to develop the value of Welsh in the workplace
- Promote Welsh culture, history and heritage in lessons where appropriate
